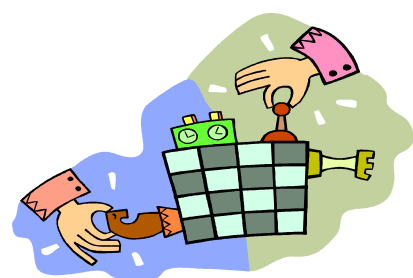

Call to Order –President Lynn Johnston called the meeting to order at 6:31 p.m. Board Members in attendance were Steve Harenberg, Gary Smith, Brian Woertz, William Whitehurst, Cathy Doss, Leah Allison and Matt Buczynski. Steve Schmidt arrived late. Also present was Glenda Carlson, General Manager.

Approval of Minutes – Bill Whitehurst made a motion to approve the October, 2014 minutes, seconded by Steve Harenberg. Motion carried.

Finance Report – Treasurer Leah Allison presented the Finance Report for October, 2014. Cathy Doss made a motion to accept the Finance Report as presented, Gary Smith seconded. Motion carried.

Recognition of Members and Guests – In attendance was Collin Cochran, Lot 686; Brian Cunningham, Lot 86; Jim Sinclair, Lot 477; Vickie Mulligan, Lot 186; Mike Johnston, Lot 498; Dave Johnston, Lot 479; Max Bryant, Lot 402; Dennis Ryza, Lot 1004; Janis Earle, Lot 53; Sabrina Petesch, Lot 188; and Beth Emhoff, Lot 985.

Committee Reports

Infrastructure – Jim Sinclair was present and reported that his committee had presented forms to the board for all members to be able to make recommendations on needed capital improvements, suggestions and ideas for funding, etc.. Once approved the capital improvement will be placed on the long range planning form and costs to perform and complete the improvement will then be investigated by the Infrastructure Committee for proposal to the Board. The Board is reviewing the forms and will be ready to discuss them at the December meeting.

Land and Lakes – Steve Harenberg reported that the project on the lower dam is finished and the Merry's have indicated they are pleased with how it looks. Steve further reported that the Committee is working on the cost estimates for the Dam & Bridge Repairs recommended by Foth, for both short term and long term as the Board requested. Please read their report on Page 10. After some discussion on the results of the Bathymetric and Sedimentation Maps, it was agreed that the Land and Lakes Committee will be joining with the Infrastructure/Long Range Planning Committee to adopt a proposal for presentation to the board on a 30 year Sediment Removal Plan with estimated costs.

Health and Environment – Gary Smith -NO REPORT

Covenant Review – Co-Chairman Janis Earle reported that the Committee is awaiting results of the voting by ballots which have previously been mailed to all owners and are due to be returned by November 28, 2014. Once tallied and the changes finalized, the new document will be prepared for print of Members books and to be filed at the Courthouse.

Nominating Committee - Bill Whitehurst reported that the Committee is encouraging all Members to turn their ballots in for a vote. The ballots will be counted by the Nominating Committee and the New Board Candidates will be announced at the Annual Meeting. Discussion then ensued on the voting privileges of the Membership. Reference was made to the Lake Camelot By-laws and questions answered by the Board with clarification by Member Sabrina Petesch. It was determined, as it has always been in the past, that the rule as it is written is one member, one vote.

Security Report – Brian Emhoff was unable to attend the meeting due to illness but gave a verbal report to the management office. Rounds are still being made, checking buildings, RTA property, lakes and docks. No violations to report. Security is still providing service for the Activities Club at the Junior High Dances monthly.

Club Reports

Activities Club- Glenda Carlson reported, in the absence of Board Liaison Cathy Doss, that the Santa Breakfast is coming up Saturday, December 6, 2014, from 8:30 a.m. - 11:00 a.m. The next Trivia Night will be January 9th, 2015 to benefit the Thurman family. The Committee donated \$100.00 to Santa's Hospital Helpers and decorated the Clubhouse with garland around the windows and other areas. The Christmas tree will be set up at a later date. The December meeting has been cancelled.

Sportsman's Club - Bill Whitehurst reported that the Sportsman's Club is again hosting the New Year's Eve Celebration at the Clubhouse. Tickets are currently available at the office. They are \$15.00 for one or two for \$25.00 and include drinks, hors d'oeuvres and a champagne toast. The Committee made monetary donations to St. Johns, Santa Hospital, and the Glasford HS Bass Team. Work on the upper board dock will be completed in the spring 2015.

OLD BUSINESS

2014 Violations-Security completed a new yard light inspection and violation notices, along with fines for repeat offenders, will be sent out in the next few days. Two issues of shed placements and two non-removal of trees from the lake continue to be addressed with the owners by management and management hopes to report back to the board next month on plans of resolution.

Reserve/Replacement Study: Still In Progress

Callicotte Landscaping/Payment Request - The General Manager had reported to the board receipt of a bill from Gaunt Enterprises whom provided the long-stick removal of the silt at Harker's Corner. Mr. Callicotte has agreed to the direct payment to Gaunt, both will sign a lien waiver stating as such and work order changes for any additional monies needed to complete the project will be made before the work is done and will not exceed the cost limitation previously approved by the board of \$25,500.00

Critter Control: Critter Control trapped one beaver on the lower lake. Now that the hunting season has opened up our resident trapper and the trapper we used last year recommended by Member Dustin King have caught an additional three beavers. It was also reported that they have caught several raccoons and a possum. Additional sighting of the work of any beavers should be reported to the Management office.

Santa's Hospital Helpers - Please bring your new, unwrapped gift for a child to the office and it will be picked up for delivery to the Children's Hospital to children whom are in the hospital over the Christmas holiday by Santa's Hospital Helpers. Minutes - Land & Lakes Committee
Wednesday, October 1, 2014

Call to Order: Meeting was called to order at 6:30. In attendance were Glenda Carlson, Collin Cochran, Glen Delorme, Lynn Gosnell, Steve Harenberg, John Hecker and Bruce Wheelchel.

Report on the September 17th Board Meeting: Collin Cochran and Steve Harenberg gave a brief report on the meeting.

Erosion Control Project Number 1 (from 2013): Collin reported that the grass is still coming up but feels there may be a problem that needs to be addressed where water runs off the street through the Merry's property. We might need to check with the Road Commissioner to see if there is anything he could do to prevent the erosion. It may be a problem that we need to watch; we can re-address as needed.

Dam and Bridge Inspection Reports:
1. Dam Inspection Report from Foth - No progress to report.
2. Bridge Inspection Report from Foth - No progress to report.
The committee is in the process of researching repairs for the bridge and spillway. Steve Harenberg reported he is meeting with UCM in the upcoming week and will be able to provide some cost estimates. Bruce will be contacting his sources to continue to get cost estimates. Bruce, Steve and Collin will continue work on these projects to obtain information for the board regarding both short term repairs and long term major repairs and/or replacement.

Erosion Control and Siltation Projects for 2014
Siltation Pond at the West End of Lake Lancelot:
Work completed:
1. North and South bank of silt pond: Dredged siltation pond with Long Reach Excavator in area that could not be reached with other excavator.
2. Dredged West end of Lake Lancelot with Long Reach Excavator- Has about 1 more day of work
3. Lined both sides and top of the new "access road to the south bank of silt pond" with rock, -might need a little more rock.
Work remaining includes:
1. Reshape area and haul dredged material after allowing at least a month to dry out
2. Build check dams
3. Cleanup areas and reseed

Collin reported that somebody took four or five truck loads today in two spots where if it rains as projected we may have a wash out. Silt fences have been placed on both sides to prevent washing into the lake. Collin asked for rolls of caution tape to tape the area off, preventing people from taking any additional dirt at this time. Steve Harenberg stated he would get caution tape for Collin.
Siltation Pond at the North End of Lake Camelot:
Work remaining:
1. Dredge with Long Reach Excavator in area that could not be reached with other excavator.
2. Minor cleaned-up and reshaping

Erosion Control and Silation for 2014:
1. **Removing Lake Siltation:** Glenda informed the Committee that the Board has received the bathymetric and sediment study maps from The Mapping Network and are preparing them for distribution to the Committee. The Committee will discuss further when more information is available.
2. **Strategy for working with neighboring land owners to control erosion into our lakes:** Bruce reported that the meeting with the USDA & area landowners went well and feels we have begun a working relationship that needs to be continued. Another possible meeting for February with preparations for an agenda should be in the works. Bruce will contact the gentlemen at the USDA to discuss. He also reported that the USDA people are willing to work with us to develop plans to solve the erosion problems that we have identified. He will schedule a meeting to look at the problem areas, after vegetation has died down.
3. **The park access area that runs between Tewksbury and Canterbury:** Bernie continues to make progress. The committee discussed the e-mailed report he submitted.
4. **Developing plans for working on additional prioritized erosion problem areas:** The committee discussed the Budget Plan that we submitted to the Board and the funds that might be available for 2015 projects. Glenda reported to the committee on funds spent on projects in 2013 and 2014. She also brought the committee up to date on funds remaining for the on-going erosion control and siltation project for 2014 and the projected balance that will carry over to 2015.

Dam Safety & Maintenance Manual that includes our Emergency Action Plan: Deb will acquire the remaining few names from the residents along Lancaster Road.

New Business:
1. The Committee would like to thank the maintenance department, Greg Dennis and Dennis Woods, for hauling the remainder of the rock that needed to be moved at Project #1.

Minutes - Land & Lakes Committee
Wednesday, November 5, 2014

Call to Order: Meeting was called to order at 6:30. In attendance were Collin Cochran, Brian Cunningham, Glen Delorme, Lynn Gosnell, Steve Harenberg, Richard Novitsky, Deb Metroff, and Bruce Wheelchel.

Report on the October 15th Board Meeting: Collin and Steve gave a brief report on the meeting.

Erosion Control Project Number 1 (from 2013): Collin reported that the Merrys are satisfied with the job that was done. Committee agreed it would be a good idea to invite them to the Volunteer Dinner; Collin will contact the RTA office.

Dam and Bridge Inspection Reports:
1. Dam Inspection Report from Foth
2. Bridge Inspection Report from Foth
The committee is in the process of researching repairs for the bridge and spillway. Bruce has contacted contractors for the short term work. Bruce is waiting on pictures that show problem areas on both the spillway and bridge; hopes to have them in the near future. Steve is anticipating a quote from UCM. Bruce, Steve and Collin will continue work on these projects to obtain information and get cost estimates for the board regarding both short term repairs and long term major repairs and/or replacement.

Erosion Control and Siltation Projects for 2014
Siltation Pond at the West End of Lake Lancelot:
Work completed:
1. Dredged West end of Lake Lancelot with Long Reach Excavator
Work remaining includes:
1. Might need more rock on both sides and top of the new access road to the south bank of silt pond
2. Reshape area and haul dredged material after allowing the material to dry out
3. Build check dams
4. Cleanup areas and reseed

The sub-contractor that completed the long stick excavating did very good job dredging the silt pond and the West end of Lake Lancelot. The contractor will finish the project once the dredged material dries and weather allows. Collin reported that the following items still need to be addressed: 1) some of the silt cloth needs to be fixed, 2) some rip-rap needs to be pulled out of the lake (from previous project), 3) the benches on both sides need to be built higher, 4) The dredged material is crusting and appears to be drying, and 5) the caution tape and posts need to be replaced. If the weather cooperates, it is the Committee's goal is to have the project completed this fall.
Siltation Pond at the North End of Lake Camelot:
Work completed:
1. Dredged with Long Reach Excavator in area that could not be reached with other excavator
Work remaining:
1. Minor cleaned-up and reshaping

Committee Goals and Lakes Management Plan - 1) for 2015 & 2) Long Range
Committee discussed the proposed 2015 budget and estimated that we have approximately \$30K in our budget for 2015 projects. The Committee agreed that it is important to stay consistent and continue with the goals we set and worked on for the past three or four years. The Committee also agreed that our *Lakes Management Plan* should be our guide for both 2015 projects and long range planning. Our primary focus should continue to be on 1) Erosion Control, 2) Sediment Removal, & 3) Aeration. The committee feels that we need to get erosion under control before proceeding with removal of lake sediment and aeration. The Committee also needs to focus on the *Dam Inspection* and *Bridge Inspection Reports* regarding the repair and/or replacement of the Lake Lancelot spillway and the Lake Lancelot bridge

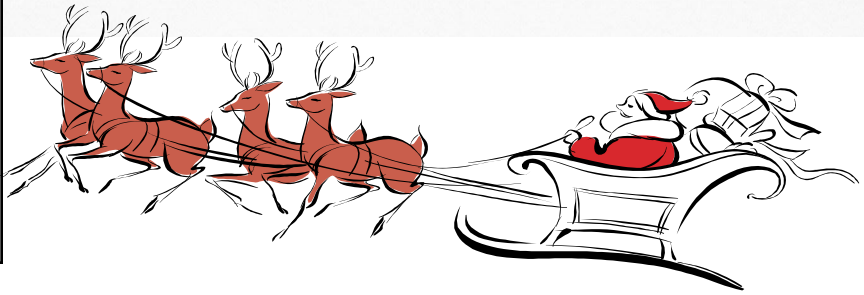
Erosion Control and Silation:
1. **Erosion and Lake Siltation:** Discussed the results of the *Hydrographic and Sediment Survey* and how they impact the Committee's Lakes Management Plan, and the committee's direction for moving the Plan forward by considering the following: 1) Identify and prioritize problem areas, 2) Determine what caused the problem: soil erosion or organic decay, 3) Determine source of soil erosion - RTA property or adjoining properties, and 4) Determine source of organic decay. The committee will review the data from the *Hydrographic and Sediment Survey* and discuss at our next meeting.
2. **Plans for meeting with the USDA-NRCS to control erosion into our lakes:** Discussed plans for meetings with Scott Wallace and Gary Gorden (USDA-NRCS) to review and discuss: 1) the erosion problem areas that we have prioritized, 2) the results of the Hydrographic and Sediment Survey, 3) possible solutions to our erosion problems, 4) a schedule and agenda for a followup meeting with neighboring land owners, and 5) possible funding sources. Bruce will follow through on this.
3. **The park access area that runs between Tewksbury and Canterbury:** Bernie continues to make progress. The committee discussed the e-mailed report he submitted.
4. **Developing plans for working on additional prioritized erosion problem areas:** Discussed methodology for work on prioritized erosion areas that includes: 1) brainstorming ideas to solve/fix the problem areas, 2) evaluating and rating the ideas, 3) selecting the best way to solve/fix the problem areas, 4) estimating costs for prioritized projects, 5) developing plans for projects for 2015 (including costs based on bids), and 6) estimating long term budget for future projects.

Dam Safety & Maintenance Manual that includes our Emergency Action Plan: We should have completed by the end of the year.

New Business:
1. Discussed the committee's *Annual Report* to the membership at the December 7th Annual Meeting. Committee agreed to follow the same format that we used last year. Bruce will update with help from Collin. They will try to email a copy before our December 3rd committee meeting.
