

BOARD OF DIRECTORS MEETING
Wednesday, June 20, 2014**

Call to Order –President Lynn Johnston called the meeting to order at 6:30 pm. Board Members in attendance were Matt Buczynski, Leah Allison, Steve Harenberg, Gary Smith, William Whitehurst, Cathy Doss and Brian Woertz. Steve Schmidt arrived @ 8:30 p.m. Also in attendance was Glenda Carlson, General Manager.

Approval of Minutes – Bill Whitehurst made the motion to approve the May 21st, 2014 meeting minutes. Motion seconded by Cathy Doss. All in favor - Motion carried.

Finance Report – Leah Allison presented the Finance Report. Monthly Income and Expense statement was reviewed for May 2014. Brian Woertz made a motion and Gary Smith seconded to accept the financial report as submitted. Motion carried.

Recognition of Members and Guests – In attendance were Jim Sinclair, Collin Cochran, Dave Johnston and Emily & Parker Alwood. Emily made a presentation to the board requesting the formation of a Lake Camelot Yoga Group to be allowed to use the clubhouse facilities for a one hour yoga session either on Tuesday or/+ Thursdays; her being in charge of its implementation, board approved. The Board requested scheduling to be done in conjunction with the clubhouse availability through the management office.

Committee Reports

Infrastructure – Jim Sinclair gave the Board an updated report on the proposed bathroom renovations. He had feedback from Contractors, County building permit needs and estimated costs. The committee will continue to work with the board on this project.

ECC Reports-All ECC applications were approved with the exception of one. Lot 594-Replacement of Concrete Patio, approved; Lot 163-Installation of Retaining Wall/Replace Septic Drain Tiles, approved; Lot 815-Replace & Add to Existing Driveway, approved; Lot 52/53-Landscaping/Add Steps and Blocks around Patio, approved; Lot 674-Replace timber wall with block, approved; Lot 876-Addition of Sidewalk, approved; Lot 212 & 213- Reapprove application of project not finished within 6 month time frame, previously accepted, approved; Lot 336- Installation of Shed, approved; Lot 881/882- Request Contiguous Lot Status- not approved. Bill Whitehurst made a motion to accept all ECC applications with the exception of Lot 881/882., Brian Woertz seconded, all in favor.

Old Business

2014 Violations/Tree Removals– Letter from Attorney reviewed and to be mailed out regarding tree removals to all owners with trees that have fallen in the lake that have not yet been removed. Yard light inspection was performed and letters sent warning 51 owners needing to correct. A second inspection will be performed in thirty days. Violators whom have not complied will receive a notice of fine in accordance with the LC fine Structure..

July 5th Fireworks Celebration- The General Manager reported on the event planning process and the permit has been received from Chief Tuttle to allow us to have our fireworks performed at the fourth of July celebration. Cheerleaders have been informed they will be allowed to have a bake sale and face painting, but selling of the glow bracelets/necklaces will be through the Activities Club.

Reserve Study Progress- Update by Reserve Study Program not yet received.

Lot 706- Redemption period has passed. Pekin residents purchased property for back taxes. We will now start receiving dues on Lot.

Community Clean up-Day - The General Manager reported Community Clean up Day was a success. Attended by 25 to 30 people a lot of work was done to the RTA community property in an effort to clean up and assist management in preparation of the fourth of July event coming up soon. The board would like to thank the community members who did come out to volunteer and thank them for their continued support!

Neighborhood Link/Community Web Page - General Manager reported several members have joined the new community web page and will continue to encourage members to join at www.CamelotRTA.org for official association business.

New Business

Pool Privilege Incident/Age Requirements for Admission – The General Manager reported an incident involving a minor child whom lives in Lake Camelot had occurred where the minor had to be expelled and not permitted back in to the pool until the situation could be discussed. After much discussion, Matt Buczynski made a motion, seconded by Gary Smith that said child would not be allowed back into the pool without one of his parents for the remainder of the 2014 swimming pool season. Additional violations will result in privileges for use of any other Lake Camelot amenities also being revoked. Motion carried. Further management was instruction to continue to enforce pool rules that no one under the age of 16 will be allowed to watch younger children in the intermediate or wading pool and that all children must be over the age of 12 in order to gain admittance into the facility without an adult 16 or older..

Lake Spraying Report- The granular has been received and applied but will take approximately 1 to 2 weeks to show the benefits of application. Monitoring of the lake weeds continues by the maintenance department.

Logan Township Road Signs – They will begin the process of changing out the Signs (speed, stop, etc.) to make them retro-reflective as required by the state.

Greetings, the amount of calls we have been running lately has gone up. As I write this, my final article for the paper, we have run a total of 225 calls this year. The biggest trend we have seen is an increase of mutual aid fires that we have responded to outside the district. Our Camelot crew has been sent out on several of them and has done an excellent job working with the other districts to get the fire out, provide coverage for their districts during the fire, and return home safe after every call.

Recognition time..... I would like to recognize Candy Williams for going above and beyond the call of duty on a recent call. Candy rode the ambulance with a patient to keep them calm preventing further agitation of their injury and assisted the medics with the patient care. Candy also accompanied the patient all the way to their exam room. This is something that we normally do not do as there is very limited space in the rigs as the medics provides patient care. The department and the Lake Camelot fire/rescue team will definitely miss Candy as she will be resigning as of August 1 after 6 years of service. I would also like to Congratulate Bud Vest. Bud was chosen as my replacement as Captain of the Lake Camelot firehouse and he will take lead as of July 1. Finally, I would like to recognize the entire LC crew (Capt. Monte Barrick, Capt. Bud Vest, Candy Williams, Judi Dansizen, Jim Berger, Josh Rademaker, Phil Smith, Kyle Gerard, Connor Pardieck, Marcy George, Avery Jordan, and Ethan Theyse) for all their hard work so far this year responding to calls at all hours, providing patient care, and working in some extremely tough and stressful environments. I will officially resign from the department as of August 1 as Candy and I will be moving from the area for my work. Again, it has been an honor and privilege serving this community. Good luck, we will miss all of you.

Minutes - Land & Lakes Committee

Wednesday, June 4, 2014

Call to Order: The meeting was called to order at 6:30 p.m. Committee members in attendance were Glenda Carlson, Glen DeLorme, Lynn Gosnell, Steve Harenberg and Bruce Whelchel. Collin Cochran arrived at 7:07 p.m.

Report on the May 21st Board Meeting: Steve Harenberg stated he had reported to the Board on the status of the Committee's projects that are in progress.

Erosion Control Project #1 (from 2013); We have made great progress. Fire Master Collin Cochran was in charge of burning the large wood pile and with the help of other committee members the fire was ignited for several hours with periodic checks throughout the evening and again the following day. The committee thanks Collin for all his efforts in preparing for and completing the burning. The committee also thanks Danny Bushart and Gary Gonigam for their help in preparing the piles for the burn; we appreciate their time and effort. The committee also recognizes the Merry's Lot 823, and thanks them for their patience and consideration in allowing us access to work on this project; they were very kind and a pleasure to work with. Work remaining on the project includes: 1) cleaning up the logs that did not burn, 2) additional site grading and filling big holes, and 3) final grading and seeding. Weather permitting, the project should be completed next week. To date we have spend approximately \$4,500; another \$1250-\$1300 will be need to complete the project. The project will come in under the \$7500 budget. The Merry's were contacted about work they had thought they might want to do on their property; they decided they will wait until a later date to complete their projects.

Dam and Bridge Inspection Reports:

1. Dam Inspection Report from Foth - Overall the report was good except for the lower dam spillway that was sited for maintenance and repairs. The report states that in addition to short term fixes we need to plan for long term and costly, major repairs.
2. Bridge Inspection Report from Foth - Overall the report was not good, the bridge was sited for maintenance and repairs. The report states that in addition to short term fixes we need to plan for long term and costly, major repairs.

For both the spillway and the bridge, Bruce is working on getting costs from 2 or 3 companies for engineering and repair costs. The committee would like the Board's approval before we bring people in and get estimates for minor repairs and/or for major repairs or replacements. Steve H. reported that he has a contact at UCM that we might be able to work with for estimates.

Erosion Control and Siltation Projects for 2014 - The North end of Lake Camelot and the West end of Lake Lancelot: The contractor has been completing preliminary work to prepare the sites. He has been clearing the areas with his smaller equipment. Road restrictions have recently been lifted by the Road Commissioner and the contractor will be moving the larger equipment in the near future. The contractor is going on vacation the week of the 13th and the major work will probably start on the 23rd. Plans are to complete move of the work with lower cost equipment and only rent the more costly long stick excavator the last couple of days.

Erosion Control and Siltation for 2014:

1. **Removing Lake Siltation:** Richard Novitsky continues to compile information needed for siltation removal. Bruce talked to Nate Herman about a report he had prepared for Lake Camelot in 2009. Bruce received a copy of the report but it did not have siltation readings. Bruce will send a copy of the report to committee; he will also see if he can get the information on siltation depths that were taken in 2009. Bruce reported that Nate would be glad to meet with us later this summer after he completes his busy season.
2. **Strategy for working neighboring land owners to control erosion into our lakes:** Deb, Glenda and Steve S. are waiting for the busy part of the Season to pass for the agricultural people and hoping to be able to set up a joint meeting with the help of Scott Wallace and Gary Gordon from the USDA-NCRS prior to the Fall.
3. **The park access area that runs between Tewkesbury and Canterbury:** Bernie submitted a written report that he has almost all of the concrete hauled down to the park access area. Loading it in 5 gallon buckets, haul in garden cart, then hand carry each bucket 80 feet for placement on dry dam. Lawn tractor broke down, had a week delay waiting for it to be repaired. About 180 buckets so far. Most of the concrete has been set to the side until he could get stand-pipe installed. He will be purchasing stand-pipe material for proper reimbursement. The Committee would like to thank Bernie for all of his hard work.

New Business:

Budget Planning: By the 1st of October we will need to prepare to report to the Board, that will help them plan the 2015 budget as well as plan for long range expenditures. Last year's submission was stapled to the back of the meeting agenda for committee member's review. Bruce suggested using the same format unless the committee would like to develop a different format. Members were asked to begin thinking about input to review at the next couple of meetings.

Community Clean-Up Day: The clean up day is scheduled for Saturday, June 7, 2014. All members are invited to attend. Drinks, Snacks and Pizza are being provided to those that help to clean up RTA property and amenities.

Dam Safety and Maintenance Manual that includes our Emergency Action Plan: Bruce has compiled a partial list but is missing some of the phone numbers from the names and addresses of everyone whom lives downstream from the Lake Lancelot Dam. Bruce gave Glenda the list and asked she research the information need so that we can complete the Dam Safety & Maintenance Manual and Emergency Action Plan.
