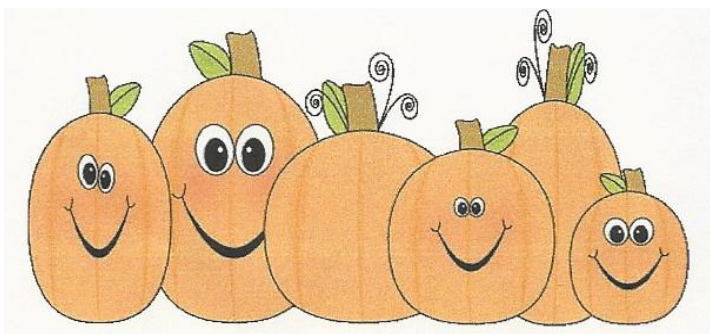

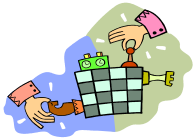

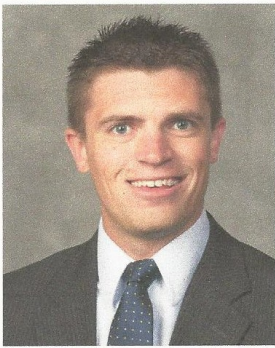

BOARD OF DIRECTORS MEETING
Wednesday, September 17, 2014
(un-approved meeting minutes)

Call to Order –President Lynn Johnston called the meeting to order at 6:32 p.m. Board Members in attendance were Steve Harenberg, Steve Schmidt, Gary Smith, Brian Woertz, William Whitehurst , Cathy Doss, Leah Allison and Matt Buczynski . Also present was Glenda Carlson, General Manager.

Approval of Minutes – Cathy Doss made a motion to approve the August, 2014 minutes with one auto word correction (cost to coat), seconded by Leah Allison. Motion carried.

Finance Report – Leah Allison presented the Finance Report. Monthly Income and Expense statement was reviewed for August 2014 and approved.

Recognition of Members and Guests – In attendance was Collin Cochran, Brian Cunningham, Greg Dennis and Brian Emhoff.

Committee Reports

Infrastructure –Matt Buczynski reported on the bathroom project of refreshing the two main floor bathrooms. Costs and selections are being put together for board review. Matt has suggested that a simple process of 1) identifying needed repairs, replacement and upgrades from Board, RTA Committees. Staff and Member input; 2) assess the timing of the needs; 3) determine approximate costs involved; 4) present information to the budget committee; 5) obtain final quotes and contract agreements and 6) once approved, make sure the work is completed in a timely manner. His committee is in the process of developing a tracking and reporting system that can be charted and followed by the community and published in the monthly newsletter for all upcoming long range planning projects. More information should be available at the next meeting.

Land and Lakes –.Steve Harenberg reported on the work being done at Harkers Corner and informed the board that the project continues to be delayed due to the weather. He does hope that the contractor will be able to get back on it soon and that Calicotte will also be asked to go back and remove the larger debris and/or rocks from around the project area a little better near the lower dam that was a project he had worked on earlier in the year. The board would like people to call the office or the contractor before taking dirt at the back entrance (Please Read L&L Report, Page 7.)

Health and Environment – Gary Smith -NO REPORT

Covenant Review – In accordance with the timeline set, Lynn Johnston reported that the Board met at a Special Meeting of the Board with member Sabrina Petesch this last week and were able to review the proposed changes to the Declaration of Restrictive Covenants. Due to time constraints another date had to be set to continue the review which will include a review of the proposed changes for the association by-laws.

Security Report – Brian Emhoff reported that things have been relatively quiet, however, he did want to mention that he has noticed a lot more trash being left by patrons on the lakes and in the surrounding common areas. The board would like to ask members to **HELP KEEP LAKE CAMELOT CLEAN.** Please dispose of all trash in receptacles placed on Association property throughout the area. If you are unable to locate a receptacle please throw your trash away in the dumpster located at the clubhouse facility. While the dumpster is not for members personal use it is for use of trash and debris while visiting Lake Camelot amenities when other trash receptacles are full. We appreciate your help in keeping Lake Camelot clean.

Club Reports

Activities Club- Cathy Doss reported that the first teen dance of the season is this Friday, September 19, 2014. They are every third Friday night each month for the remainder of the school year. Chaperones are always needed. Trivia Night is October 10th to benefit Tazewell County Resource Center. Jenny Cruit is organizing this event. Sportsman’s Club - The club is getting ready for the Pig Roast to be held on September 20, 2014. Tickets are available at the Lake Camelot Office. Bill Whitehurst reported the pig is being roasted here on the property by members and the Board would like to thank all the helpers that will make this happen.

ECC Reports - Approved – Lot 927 Retaining Wall/Concrete Pad; Lot 215A, 215 and 216- Contiguous Lot Status; Lot 91-Dock Repair; Lot 1001- Dock Replacement; Lot 644-643-Stone Fire Pit; Lot 86-Replace Block Wall; Lot 870-Hillside Shed and Lot 1005 Seawall Repair. Bill Whitehurst made motion and seconded by Steve Harenberg to approve the ECC applications as submitted, Motion carried.

OLD BUSINESS

2014 Violations- No Update

Lake Spraying/Update: Greg Dennis reported that there was no additional spraying to report since the general managers report on them at the last meeting. Greg informed the Board that they are seeing some green on the lakes that appears to be duckweed that they had treated as like by the water tower this year. They have scheduled a spraying to address this issue for Friday, Sept 19th. Signs will be placed at the entrances and on the webpage to inform members they will be spraying.

Reserve/Replacement Study: Still In Progress

Tennis Court/Repairs-Maintenance has been filling the cracks and applying a colored topcoat and will continue to work on this once the remainder of the materials have been shipped.

Mapping Bids: The Mapping Network people are working to have the final maps sent to us by the end of this week or the first part of the following week. Upon receipt they will be forward to the Board for review.

Fish Stocking: The General Manager reported she had spoken with Nate Herman from Herman Brothers and they will have 8”-10” channel catfish available to us for delivery the last part of October or the first couple weeks of November. 500 each lake \$1.00 per fish and \$75.00 delivery charge. The office will be notified of the delivery date once it is available.

Nominations Committee-The Nominating Committee Chairman Bill Whitehurst reported that we have four members that have been nominated and they are: Cody Martzluf, Lot 1002; Vickie Mulligan, Lot 186; Leah Allison, Lot 492 and John Hecker, Lot 350. Members have until September 25th to nominate a member to run or to go to the office and fill out a candidate letter of commitment if they are interested themselves in running for the board. Candidates will be announced in the November Newsletter with ballots sent out by November 1st. Winners revealed at the Annual Meeting of the Membership on December 7th.

LED Lighting Program: S & S is waiting for the bulbs to come in. Installation being done with a program in conjunction with Ameren, We pay \$249 only! LED light fixtures will be installed in the clubhouse with a cost savings over the year in the \$1,000’s of dollars.

USDA/Land & Lakes Meeting: The Meeting was held on September 15th with some of the area farmers and presentations were made by the Land and Lakes Chairman Bruce Whelchel, USDA Representatives-Scott Wallace and Gary Gordon, and Josh Joseph from the Peoria County Soil and Water Conservation District. Each shared valuable information and future plans for meetings were discussed to continue working together to resolve erosion control problems.

Parking Lot Bids- The additional bid requested from Pekin City Coal and Ice has been received and all four have been forwarded to the Infrastructure Committee for further review.

Critter Control: No response from current trapper. Discussion was held with regards to trapping season beginning November 1st and a request by a previous individual trapper to assist us in the removal of the nuisance animal (s).

Great Job Snack Shop workers and Lifeguards in working together to make the snack shop function; keep costs down and provide our members with a variety of treats!

Halloween/Trick or Treating – Trick or Treating in Lake Camelot will be on Friday, October 31, 2014 from 5:00 – 8:00 p.m. The fire station located at the corner of Lake Camelot and Guinivere will once again participate in handing out candy and have their boot available for donations! Thank you to our volunteer fire department and we hope you will join us in making a donation.

Volunteer Dinner-The Volunteer Dinner has been scheduled for Thursday, November 13, 2014 at 6:00p.m at the Lake Camelot Clubhouse. Minutes – Infrastructure/Long-Range Planning Committee

Tuesday, September 23, 2014

Call to Order: The meeting was called to order at 6:30 PM. Committee members in attendance were Darrel Hedman, Jim Sinclair, Matt Buczynski, and Suzanne Wheeler.

Report on the September 17 Board Meeting: Matt Buczynski gave a brief report on the meeting. He stated that the Board is looking forward to the “refresh” the bathrooms costs. The maintenance staff has the time to do the work. The Board liked the idea of setting up a process for identifying and prioritizing RTA projects and listing the potential projects in the newsletter. Glenda indicated that she had some better estimated cost figures for some of the items listed below.

Club House Bathroom project: Suzanne Wheeler researched the costs (from several possible vendors) of the list provided by the RTA staff for the two main floor bathrooms in the club house. She recommended that the RTA purchase ADA approved fixtures so they will not have to be replaced in the future. Jim Sinclair will summarize the costs to be presented to the Board.

Long-Range Planning project: Darrel presented his form and process to the committee. Several changes were suggested to the form. The committee will review the process and provide Darrel feedback. The revised form and process will be presented at the next Board meeting.

Potential Projects in Next 5 – 10 Years: The committee revised the below listing to include a “responsible committee” (the committee responsible to determine scope of work, obtain quotes, and make recommendation to Board) column. This list was updated with relevant information.

Minutes - Land & Lakes Committee
Wednesday, September 3, 2014

Call to Order: Meeting was called to order at 6:30. In attendance were Glenda Carlson, Collin Cochran, Glen Delorme, Lynn Gosnell, Steve Harenberg, Keith Johnson, Deb Metroff, and Bruce Whelchel. Guests in attendance were John Hecker and Cathy Doss.

Report on the August 20th Board Meeting: Collin Cochran gave a brief report on the meeting.

Erosion Control Project Number 1 (from 2013): Appears that the grass is starting to take hold. Area needs cleared of rocks and sticks to enable the mowers to maintain the area.

Dam and Bridge Inspection Reports:

1. Dam Inspection Report from Foth - No progress to report.
 2. Bridge Inspection Report from Foth - No progress to report.
- The Board has requested that our committee research repairs for the bridge and spillway. They would like estimates for both short term repairs and long term major repairs and/or replacement. Bruce, Steve and Collin will work on planning for these projects.

Erosion Control and Siltation Projects for 2014 (There has been little to no progress in this area due to the weather.)

Siltation Pond at the West End of Lake Lancelot:

1. North bank of silt pond: Dredge siltation pond with Long Reach Excavator in area that could not be reached with other excavator.
2. Dredge West end of Lake Lancelot with Long Reach Excavator
3. Reshape area and haul dredged material (As part of the bid, the contractor has rights to the material)
4. Line both sides and top of the new “access road to the south bank of silt pond” with rock.
5. Build check dam.
6. Cleanup areas and reseed.

Siltation Pond at the North End of lake Camelot:

Work remaining:
Minor clean-up and reshaping

Erosion Control and Siltation for 2014:

1. **Removing Lake Siltation:** Glenda passed out information from the Bathymetric and Sediment survey on both lakes. The committee discussed the preliminary results and how they impact the Committee’s Lakes Management Plan and direction for moving the Plan forward. The Committee will discuss further when more information is available.
2. **Strategy for working with neighboring land owners to control erosion into our lakes:** Glenda set up a meeting through Scott Wallace from the USDA-NCRS. The meeting is scheduled for 4:30 pm on September 15, 2014. Scott has sent out invitations to neighboring land owners. Bruce agreed to meet with Scott to prepare the program. The committee asked Bruce to give the presentation for the Land & Lakes Committee.
3. **The park access area that runs between Tewksbury and Canterbury:** Bernie continues to make progress. The committee discussed the report he submitted.
4. **Developing plans for working on additional prioritized erosion problem areas:** Tabled.

Budget Planning: The committee discussed our finalized *Budget Planning document* that is based on: 1) *the Lakes Management Plan* that was approved by the Land & Lakes Committee in February of 2011 and 2) the most recent *Dam Inspection* and *Bridge Inspection Reports*. The document addresses the need for budget plans in four areas: 1) plans to address erosion problems contributing to lake siltation, 2) plans to address siltation removal, 3) plans to address aeration, and 4) plans to address the dam inspection and bridge inspection reports. The committee feels that the RTA needs to develop a multi-year plan that addresses both short term and long term goals and funding. The plan could take the form (that we have been following for the past few years) of committing a finite budget amount each year for a large number of years; however, based on the magnitude of the problems that we are facing, the committee feels that we need to increase budgeted funds for a more specific time line. As we continue to finalize cost estimates the committee will be able to recommend more specific numbers, however, the estimates in the document should give the Board the information needed to develop both short term and long term goals and funding. Glenda and Steve will present the committee’s *Budget Planning Document* to the Board for their budget Planning Document to the Board for their budget planning meetings.

Dam Safety & Maintenance Manual that includes our Emergency Action Plan: Deb will acquire the remaining few names from the residents along Lancaster Road.

New Business:

1. Keith discussed and agreed to look into a “319 Grant” that is federally allocated by the State.
2. Cathy Doss inquired about the dirt and the unsightly condition at the North End of Lake Camelot. The Committee agreed that the weather has not allowed the contractor to get into the area with the heavy equipment; however, the contractor needs to schedule the remaining work as soon as weather allows. In the mean time, he needs to clean up the area as much as possible. Bruce and Steve will meet with the contractor to discuss the project time table.

Adjournment: Meeting adjourned at 8:16 p.m.
