

INFRASTRUCTURE/LONG RANGE PLANNING COMMITTEE (ILRPC)

Minutes – Infrastructure/Long-Range Planning Committee (ILRPC)

Tuesday, April 11, 2017

Call to Order - The meeting was called to order at 5:00 PM. Committee members in attendance were Jim Sinclair, Kevin Arduini, Suzanne Wheeler, Jeff Lox, Roger Markle, and Don Keith. Guests Not Able to attend: Glenda Carlson and John Hecker.

Report on the March 2017 RTA Meetings – Pool Deck Leveling - The Board gave us the okay to obtain at least three bids for the deck leveling. They suggested also contacting Gary Verardo in Glasford (389-4452 – confirm this number with Glenda) as a potential contractor. All contractors need to be licensed and insured. We need to have at least three bids for us to consider at our April 11th meeting so we can present our recommendation to the Board at the April 19th meeting.

Fence Painting – The Board gave us the okay to recruit community volunteers to paint the fence on April 29th beginning at 9 AM (rain/wind date May 6th). They want to make sure this is well supervised to minimize the amount of paint drops that end up on the deck. The Board gave permission to place ads in the newsletter, website page, and Facebook page. Participants must be at least 18 years of age. They also decided that we will paint it black. Kevin asked them if we should get bids from professionals to see if that is a viable option. They said yes.

Pool Complex – The Board asked when we would have our full recommendation to the Board and community. I said we have a lot of fact finding and learning to do before this will occur (similar to the dredging committee) and we could be another year before we are ready to present something to them.

Other – The vented door has been purchased and spring loaded hinges have been ordered for the small pool gates.

Pool House Roof - Kevin asked the Board about the pool house roof and any interest at this time to replace it. There is still sentiment to just fix the bad section. There is concern about spending \$15,000 to replace it and then 5 years down the road the entire complex is replaced. I said the same logic could be used about the deck leveling. I suggested that we need to investigate the roof damage more thoroughly before we can move this issue forward.

Swimming Pool Complex – Projects documented fully in the matrix include - 1) Proposal to Board to have Concrete Solutions perform the concrete deck levelling; 2) Kevin is coordinate volunteers and supplies for the 4/29 fence painting and other committee members are supplying drop cloths and step ladders; and 3) Kevin and Don will coordinate with Glenda to contact Reno Systems.

The matrix is on the Camelot Roundtable Association website’s Pages and Links page. We encourage members to refer to this for monthly updates. **We welcome members to attend the monthly meetings to gain knowledge and volunteer their expertise to help us analyze the entire complex.**

Committee Projects – No Project Request Forms were presented by the community this month.

Other possible item for 2017 consideration – Parking lots, tennis courts surface, club house deck sealing, digital signage at entrances.

REVIEW OF RTA BOARD MEETING March 15, 2017: Presented by Bill Krokos.

ILLINOIS LAKE MANAGEMENT ASSOCIATION CONFERENCE:

Glenda Carlson, Bill Krokos and John Hecker spoke about session information and ideas that will assist the association in regard to water quality management, erosion control, best practices and land owners and shoreline Stabilization. Vice President Bill Krokos received and award from ILMA for his efforts in education the RTA Board and the Lake Camelot Community on the need to improve the water quality by developing a dredging and erosion control plan and its’ association funding.

INLET BLOCKAGE NEAR LOT 214

The committee discussed methods to improve Drainage into Ravine #26 . General Manger will contact Logan Township to seek assistance. General Manager will make contact with adjacent famer to the West and North to see if any land use changes have take place that affect water drainage volume.

EROSION ISSUES AT THE END OF BUCKINGHAM CT (LOT 712):

Lengthy discussion but tabled until next meeting.

OTHER ITEMS DISCUSSED:

On going problem of illegal dumping of concrete into ravines by unauthorized contractors or homeowners.
Lot numbering for shoreline properties.
Specifications needed for erosion control in ravines completed by a qualified engineer.

SIU WATER QUALITY PROFESSOR:

Dr. Brooks is scheduled to present a PowerPoint detailing what the Southern Illinois University did to Campus Lake in Carbondale to improve water quality issues related to the infiltration of algae blooms and how lake Camelot could learn from the successes at SIU. The presentation is scheduled to Monday April 17 in the Clubhouse at 6:30 p.m. The RTA Board and Land and Lakes Committee are encouraged to attend.

WHY CAMELOT RTA IS PARTICIPATING IN THE VLMP –(Volunteer Lake Management Program)- 2ND Year Training Program

There are 3,256 lakes with a surface area of six acres or more in Illinois and more than 87,000 ponds. In addition to being valuable recreational and ecological resources, these water-bodies serve as potable, industrial and agricultural water supplies; as cooling water sources; and as flood control structures.

Lakes serve as **traps for materials** generated within their watersheds. **The trapped material generally impairs water quality and may severely impact beneficial uses and significantly shorten the life of the lake. Suspended and deposited sediments can affect certain lake uses.** Excessive aquatic macrophyte (plant) growth and/or **algal blooms** often result from the addition of nutrients such as nitrogen and phosphorus. An overabundance of plant life may tend to limit **recreational** and public water supply usage. Lakes may also collect heavy metal and organic contamination from urban, industrial, and agricultural sources. **Dissolved oxygen deficiencies may limit biological habitat** or result in taste and odor problems for public water supplies.

The program provides a service to the Agency by harnessing the time and talent of citizen volunteers to help gather fundamental information on more Illinois’ inland lakes than could otherwise be possible with existing staff. This program also serves its volunteers and the general public by opening a path for citizen involvement with the environment and providing environmental education and outreach opportunities for Illinois citizens to learn about lake ecosystems. This program also serves as a cost-effective method for gathering fundamental information on inland lakes, which ultimately leads to making better lake management decisions

Pledge of Allegiance: President Steve Harenberg asked the audience to please stand and join the Board in the Pledge of Allegiance.

Call to Order: President Harenberg called the meeting to order at 6:32 p.m. Board Members present were Leah Allison, Cathy Doss, John Hecker, Don Keith, Vickie Mulligan, Scott Perkins and Bob Wilder, absent Bill Krokos. Also present was Glenda Carlson, Acting General Manager and Jill Bleichner, Administrative Assistant.

Approval of Minutes: The General Manager stated the March minutes needed to reflect a motion made in that meeting by Leah Allison and seconded by Cathy Doss to open a reserve account for the Clubhouse Improvements separate from Swimming Pool Improvement Reserve. Bob Wilder made a motion to approve the March 2017 minutes as corrected. Scott Perkins seconded the motion. All in favor, Motion Carried.

Finance Report: Treasurer Leah Allison reported the financial statement for March 2017 to the Board and members present. The financial report was approved as presented. A motion was made by Leah Allison, seconded by Scott Perkins to open a Lake Camelot Baseball account under Lake Camelot Tax ID. require two signatures and close the old account, as had been done with the Lake Camelot Swim Team last month. These will then both be held in interest bearing checking accounts. All in favor motion carried.

Resignation: Don Keith resigned from the Board. John Hecker made a motion to accept Mr. Keith's resignation, seconded by Bob Wilder. All in favor, motion carried.

Recognition of Members and Guests: In attendance were: Dennis Woods, Lot 773; Brenda Keith, Lot 919 and Michael Haffner, Lot 616.

COMMITTEE REPORTS

Infrastructure/Long Range Planning: In the absence of Committee Chairperson Jim Sinclair, General Manager presented the April ILRP report. See Infrastructure/ Long Range Planning Minutes in the May newsletter and website.

Painting the pool fence is scheduled for April 29, 2017. Motion made by Vickie Mulligan, Bob Wilder seconded, to approve the expense (not to exceed) any more than \$1,500 in paint and supplies for the project. Motion carried all in favor.

Land and Lakes: Committee report was presented by John Hecker, Board Liaison in absence of Committee Chairman, Deb McBeath. See Land and Lakes Minutes in the May newsletter.

Fundraising Committee: Vickie Mulligan, Board Liaison gave the committee report in absence of Beth Emhoff. The metal recycling has been picked up three times. The first pick up made \$98. Vickie stated that her husband is willing to pick up for people if someone does not have a truck. The next meeting is scheduled for April 27th at 6:30 p.m.

Health and Environment: No report.

Security Report: Kris Jouchim was absent. The General Manager reported verbal and behavioral issues with a few teens at the pavilion and park in the presence of staff, parents and small children recently. Complaints have been received in the office from several parents at the playground with their children. Prior discussions by Security/Maintenance personnel have been held with the teens to no avail. The Board instructed the general manager to discuss the infractions with the involved teens parents and inform them member privileges to said minors may be suspended immediately which will include all Lake Camelot common property for the remainder of the year.

CLUB REPORTS

Motioned to accept the applications as submitted and approved by the ECC was made by Bob Wilder, seconded by John Hecker. All in favor. Motion Carried

ECC – Deadline Resolution: The Management office recommended a date prior to the ECC meeting date be set for the submission of ECC applications for the purpose of time to review, the making of the meeting agenda and the copying of the ECC applications for committee. Management submitted a resolution to the Board as written:

"The Environmental Control Committee requires all plans to be submitted to the Lake Camelot office no later than the Friday preceding the second Monday of each month when the ECC Meetings are held and plan(s) will be reviewed.

Project plans must include elevations, setbacks, sewer and septic field identification, dimensions, cross sections and materials to be used and pictures when possible. All Peoria County Permit requirement must be met; a copy must be provided to the Lake Camelot office to be put on file."

John Hecker made a motion to accept, Bob Wilder seconded. Resolution approved 5 - yes and 1 – no.

OLD BUSINESS

2017 Violation/Fines Warnings: A current list was presented to the Board. Fines will be sent accordingly. Fines for non-compliance to use and pay waste disposal bills will also be sent accordingly.

Ravine Specs/Repair/Costs Update: The General Manager has contacted engineering firms for bids on engineering specification to repair ravines.

Ameren/Advanced Metering Installation Project: No new information at this time.

Shoreline Solutions/Rip Rap Applications: Land and Lakes will have a guest at the May 3 meeting. Hank Sutton from Rip Rap Inc./Shoreline Solutions to discuss shoreline erosion control options. All members in good standing are invited to attend.

Bridge replacement update: Construction is moving forward, the bridge is still on schedule to be open November 20, 2017, no unforeseen problems or weather.

NEW BUSINESS

Storm Sewer Repairs/LC/Township Responsibility: The General Manager reported that the office has received many calls regarding issues with drainage and erosion from storm sewers. The townships are responsible for 33' from the center of the road. The Board requested a list of the property owners whom have reported with issues so they may visit and review.

Aqua-Nights/Swim Team 2017 Swim Meet Schedule: The schedule for 2017 was presented to the Board of Directors for approval. Cathy Doss made a motion to accept the swim team schedule as submitted, seconded by John Hecker. All in favor, motion carried.

BOATING REGULATIONS**1. General Regulations**

- (a) Only water craft owned by Lake Camelot Subdivision lot owners and members of Camelot Round Table Association (RTA), who are in good standing, will be allowed on the lakes.
- (b) Any watercraft deemed unsafe by the RTA Board will not be allowed or registered for use on the lakes.
- (c) The number of persons carried, load carried, equipment, (e.g., life preservers, etc.), shall be in accordance with the U.S. Coast Guard Regulations and builder's recommendations.
- (d) No boat will be allowed on the lakes after sundown without proper lights. These lights must be turned on from dusk to dawn.
- (e) For LAKE CAMELOT (upper lake). All gasoline powered engines must be raised or covered. Boat motors can be used for loading boats onto trailers at launch areas.
- (f) On LAKE LANCELOT (lower lake), traffic flow for all watercraft must be in a counter-clockwise direction.
- (g) Watercraft occupants will not deposit debris of any kind into the waters of the lakes or dock areas.
- (h) Deliberate wake jumping by boats and personal watercraft shall not be permitted.
- (i) Every boat operator is required to know and follow the regulations of the State of Illinois Boat Registration and Safety Act, the U.S. Coast Guard and the Department of Natural Resources. The preceding regulations are incorporated by reference into the Rules and Regulations, and therefore, any violation shall be considered a violation of the Rules and Regulations.

2. Registration of Water Craft

- (a) Any watercraft of a property owner that is propelled by oar, paddle, foot pedals, sail or mechanical motor must be registered with the RTA annually. To register a craft, the standard RTA registration form and the Lake Camelot Watercraft Acknowledgement Form must be completed and submitted annually along with: The original registration issued by Illinois (or the State in which the lot owner resides), if registration is required by the State, and a certificate of marine public liability and property damage insurance, if the craft is equipped with a motor exceeding 10 horsepower. The RTA office will copy these original documents and return them to the member.
- (b) Registration decals must be purchased by the lot owner for each craft registered, and these must be displayed on each side of the craft after the state registration numbers, along with the owner's lot number, on each side. Lot numbers should also be displayed on both sides of the tongue of the trailer. These lot numbers must be not less than one and one half (1 1/2) inches in height. The decals must be displayed by April 1st of the current year to be on the lakes. Decals from the previous year expire March 31st.
- (c) If watercraft registration of the boat is required, then the State's registration number must also be displayed.
- (d) The color for Camelot RTA decals and the purchase price will be determined by the Board each year.
- (e) Any person owning water craft not displaying a current Camelot RTA registration decal and lot number, as directed above, shall be subject to monetary penalty and/or suspension of boating privileges. Any boat found beached and left on any Camelot RTA out lot or common property, which is not displaying a current Camelot RTA decal and lot number, shall be impounded by the Camelot RTA Board and will be subject to monetary penalty and/or suspension of boating privileges.

3. Restrictions on Sizes and Types

- (a) The maximum boat size is restricted to twenty-two (22) feet in length per manufacturer's specifications, except pontoon boats, which may be up to twenty-five (25) feet in length.
- (b) For LAKE LANCELOT ONLY (lower lake), the maximum horsepower rating is 75 horsepower. Only outboard motors are allowed. All motors in excess of 40 horsepower must provide engine serial number prior to obtaining a boat sticker. All personal watercraft must provide serial numbers, regardless of size, prior to obtaining a boat sticker.
- (c) Any boat with toilet facilities is required to have a holding tank.

4. Speed Limits

- (a) All water craft speed limits and time restrictions are as follows: Five (5) miles per hour between dusk and dawn. Ten (10) miles per hour between dawn and 10 a.m. For Lake Lancelot (lower lake) only. Time reserved for recreational use (faster boating, tubing, water skiing, personal water craft use, etc.) is between 10 a.m. and dusk. For fishing tournaments, recreational use begins at 12:00 p.m.
- (b) Unpowered boats and swimmers shall have the right-of-way. Power boats shall stay at least thirty (30) feet away from either swimmers, unpowered boats or the shoreline, unless operating at NO WAKE SPEED. (No wake means flat water without any froth behind the boat.) The RTA management may post a NO WAKE sign as deemed necessary.
- (c) No form of boat or personal watercraft racing is permitted.

5. Water Skiing and Tubing

- (a) The provisions of the State of Illinois Boat Registration and Safety Act have been adopted by the RTA Board to be applicable to all water skiing activities on LAKE LANCELOT (lower lake). Any violation of these State laws is a violation of these Regulations.
- (b) Water skiing shall be allowed on Lake Lancelot (lower lake) from 10 a.m. to dusk.
- (c) Neither a boat towing a skier nor the towed skier may enter any NO WAKE restricted areas which are marked by buoys or which may otherwise be so designated from time to time.
- Violation of Boating Regulations 1-5. Violations of these rules by any lot owner, and/or their families or guests, will result in immediate suspension of the use of all Camelot RTA facilities, as well as fines and other penalties.




