T-Ball (4, 5, & 6 year olds)

- Boys and girls should be four years of age prior to May 1 to play T-Ball. Parents need to determine readiness of players who are four.
- Games have traditionally been played on Wednesday evenings and Saturday mornings beginning early June thru early July.
- League games may be played against Lake Camelot, Hanna City and Hollis Park.

Instructional League/Coach Pitch (7 & 8 year olds)

- Boys and girls should be seven years of age prior to May 1 to play Instructional League. Players who turn nine years of age prior to May 1 are too old to play.
- Games have traditionally been played on Tuesday and Friday evenings beginning late May thru mid July.
- League games are played with the Kickapoo Valley League (Hollis Park, Hanna City, Princeville, Brimfield, Elmwood, Farmington, and Kickapoo).

BOARD OF DIRECTORS MEETING
Wednesday, February 19, 2014

Call to Order –President Lynn Johnston called the meeting to order at 6:30 pm. Board Members in attendance were Steve Schmidt, Matt Buczynski, Leah Allison, Brian Woertz, Gary Smith, Cathy Doss and Bill Whitehurst; absent was board member Steve Harenberg. Also in attendance was Glenda Carlson, Gen. Manager.

Approval of Minutes – Bill Whitehurst made the motion to approve the January 15th, 2014 meeting minutes. Motion seconded by Steve Schmidt. All in favor- Motion carried.

Finance Report – Leah Allison presented the Finance Report. Monthly Income and Expense statement was reviewed for January 2014 . The General Manager reported the CD Account holding \$90,277.56 was up for renewal and had been held on a 2-year term but better rates were available for a 3 year term. Interest rates from three local banks were presented. A motion was made by Cathy Doss and seconded by Steve Schmidt to renew the CD for the 3 year term at Glasford Bank. Motion Carried.

Recognition of Members and Guests – In attendance were Collin Cochran, Greg Dennis, Jim Sinclair, Brian Emhoff, Max and Mary Pat Bryant.

Committee Reports

Infrastructure – Matt Buczynski reported the chairperson appointed for his committee was Jim Sinclair and would be joined by members Suzanne Wheeler and Darrel Hedman. Leah Allison made a motion to accept the members for this committee, Steve Schmidt seconded. Motion carried. The group will be meeting on the third Tuesday of each month at the Lake Camelot clubhouse and are interested in soliciting members from the community that have experience in remodeling and repair as their efforts will be focused on the clubhouse bathroom renovation upstairs.

Land and Lakes – Collin Cochran reported that Bruce Whelchel accepted the position of Chairperson for the committee and the members were the same as had previously been submitted to the Board. A motion was made by Leah Allison and seconded by Steve Schmidt to approve the committee. Collin reported on the February meeting (refer to Page 7).

Health and Environment – NO REPORT

Covenant Review – Lynn Johnston reported that the committee plans to turn its recommendations over to the board by the date specified within their timeline (02-28-14) as they are on schedule. They have completed the final reviews and are color-coding the changes for the ease of review by the board. Hard copies will be delivered to each board member through the office at the end of February. Board Members have March & April to review and discuss the changes, make recommendations before meeting with the committee in May.

Security Report – Brian Emhoff reported no security issues at the clubhouse complex or RTA property over the last thirty days. Peoria County Detective reported thefts in some vehicles in Camelot from people leaving their cars unlocked. Again, please remove your keys from your vehicle and lock it when it is not in use. Help prevent theft in the area by following these rules.

Oak Table/Replacement Costs- Three Bids were presented for the replacement of the two oak tables in the Clubhouse. The bid from Oak Express with a five year warranty plan was accepted. Order will be placed and delivery is expected within one to two weeks.

Aquatic Weed Control Class- Scheduled for March 5/6, 2014. Maintenance personnel are registered to attend.

Swim Team Coordinator/Coach - We are still in need of a volunteer to coordinate the swim team The office has received two applications for the coach positions. Interested parties should apply at the Lake Camelot office.

Minutes - Land & Lakes Committee

Tuesday, February 11, 2014

Call to Order: The meeting was called to order at 6:30. Committee members in attendance were Collin Cochran, Glen DeLorme, Steve Harenberg, Deb Metroff, Bernie Sieks, and Bruce Whelchel.

Report on the January 15th Board Meeting: Collin & Steve H. gave a brief report.

Discussion and Decision on Committee Officers for 2014: The Committee unanimously selected Bruce Whelchel to remain as chairperson for the committee, and Deb Metroff as secretary. Collin Cochran will continue to serve as associate chairperson by attending Board meetings to assist our board liaison, Steve Harenberg, with committee reports.

Discussion and Finalization of Committee Goals and Project Plans for 2014: Bruce passed out copies of *Goals & Project Planning for 2014*. The document is based on goals and project direction that were approved by the 2013 Board of Directors for last year's Land & Lakes Committee. The committee approved the 2014 Goals and Project Planning document and agreed that it should be included in the minutes for Board approval at their February 19th meeting. The document is attached at the end of these minutes (Pages 3 - 5).

Discussion of Plans for Completing Erosion Control Project Number 1 (from 2013):

Work remaining includes a trench to redirect water flow, in the swampy area, up-stream from the work completed on the erosion problem. However, not much can be done at this time due to 3' of frost. If conditions allow, the contractor will complete work in March. If needed, the contractor can also rake the total area in preparation for seeding. Project costs will come in well under budget. The maintenance staff needs to burn the wood piles as soon as the weather allows. If maintenance needs assistance, there are committee members that are willing to help. Also, we might need additional rock for two projects in this area (the contractor is available, if needed).

Discussion for Completing Work on the Lower Lake Boat Ramp: The committee discussed the area where the existing blacktop meets the new concrete. The black top is in bad shape and there is a gap with the concrete. The committee agreed that maintenance needs to purchase some QPR (cold-pack) and apply 2" layers into the gap between the blacktop and concrete. This should be done before the fisherman start putting in their boats. It might also be necessary for maintenance to rake the rock at the end of the ramp (the contractor is available, if needed).

Dam & Bridge Inspection Reports:

Dam Inspection Report: Bruce reported that we have not yet received the report.

Bridge Inspection Report: Bruce passed out the report and the committee briefly discussed. The committee members will review and be ready to discuss at the next committee meeting.

Last Year's Lake Treatment: Bruce also passed out the *Lake Camelot & Lancelot Annual Customer Service Review 2013* from Marine Biochemists. The committee members will review and be ready to discuss at the next Land and Lakes meeting. The committee agreed that they would like Greg Dennis and Dennis Woods to attend one of the next two committee meetings to discuss what their goals and plans are for treating the lakes.

2014 Budgeted funds and Projects to move forward on: Bruce met with Glenda regarding how much is budgeted for erosion control & dredging. Currently there is about \$40K available for projects. There is a carryover of \$23,616.68 and an additional \$16,000.00 budgeted for 2014. The committee agreed that we should move forward on prioritized projects in 2014.

Projects that Deal with Erosion Control and Siltation: Discussed progress and plans for work to be completed on the following:

1. **Strategy for working with neighboring land owners (with the help of Scott Wallace and Gary Gorden from the USDA-NRCS) to control erosion into our lakes:** Tabled until March, 2014.

2. **The siltation ponds at the North end of Lake Camelot and the West end of Lake Lancelot:** Bruce passed out information on the Siltation Ponds. He reported that he has met with three contractors and has cost estimates from two of them. The third contractor is running behind due to personal problems he is going through. The committee agreed that we need to act on this and have our final recommendation for Board approval at the March Board meeting. The Committee agreed that it makes sense to expand the project scope by constructing permanent work areas as well as providing access to the South Side of the siltation pond on the West end of Lake Lancelot. This will save time, cost, and effort when dredging and completing other projects that need to be done in the future.

3. **The park access area that runs between Tewksbury and Canterbury.** Bernie is still working on the park access area that runs between Tewksbury and Canterbury. The committee discussed dredging the cove (utilizing the equipment that will already be available from dredging the siltation ponds) and using that cove as a test site for aeration. We need to see if we are able to get equipment to the area and if we have a location to handle the dredged material.

4. **Meeting with Lake Wildwood on the methodology and equipment they use in solving their erosion and siltation problems:** Greg Dennis, Lynn Gosnell, Steve Harenberg, and Bruce Whelchel attended the meeting. Bruce and Steve briefly reported on the meeting; they gained a great deal of information and were very impressed with how their staff operated. If needed, they will discuss in more detail at future committee meetings. They also reported that renting their dredging equipment is out of the question; it is very large and would be much too costly to move to our Lakes. Bernie and Richard have been researching dredging equipment and methods and will share their findings at one of our upcoming meetings.

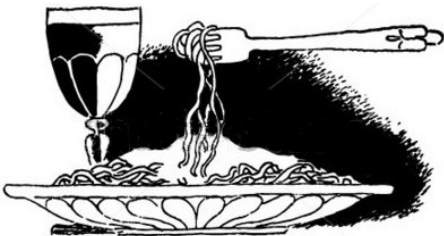
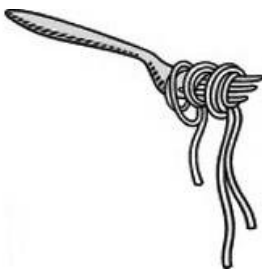

He will resume his training and path to full firefighter status when he returns in June.


